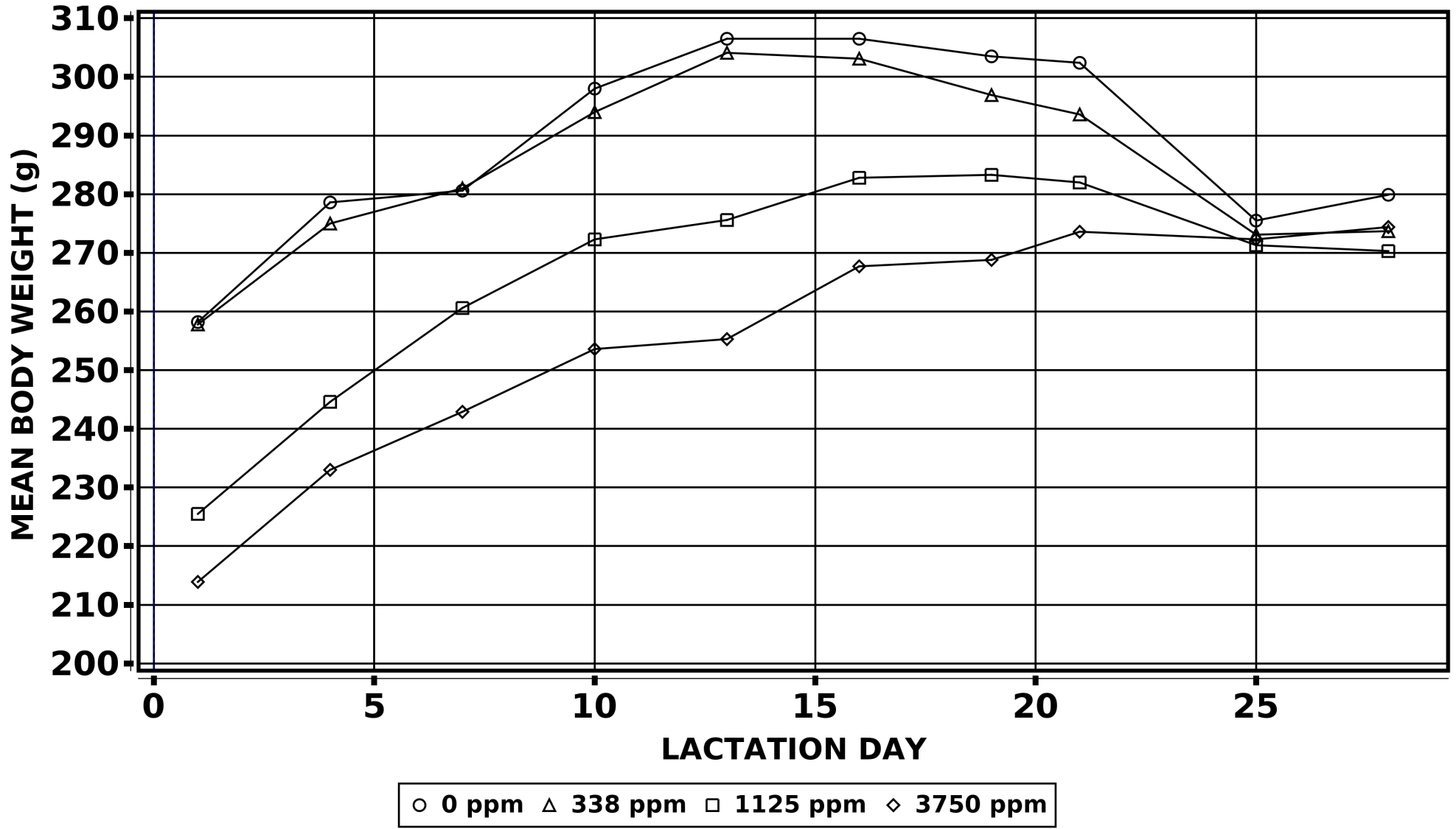

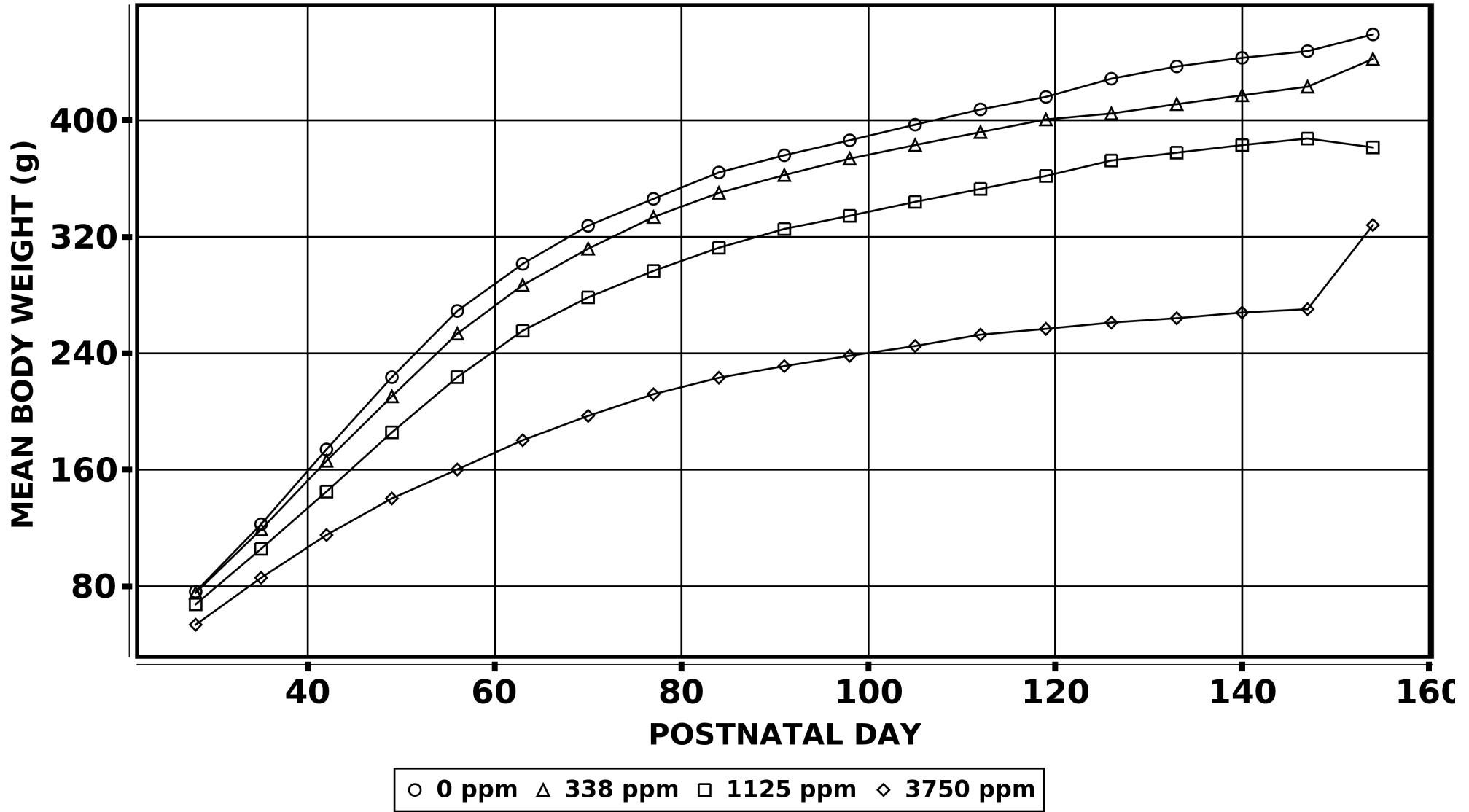

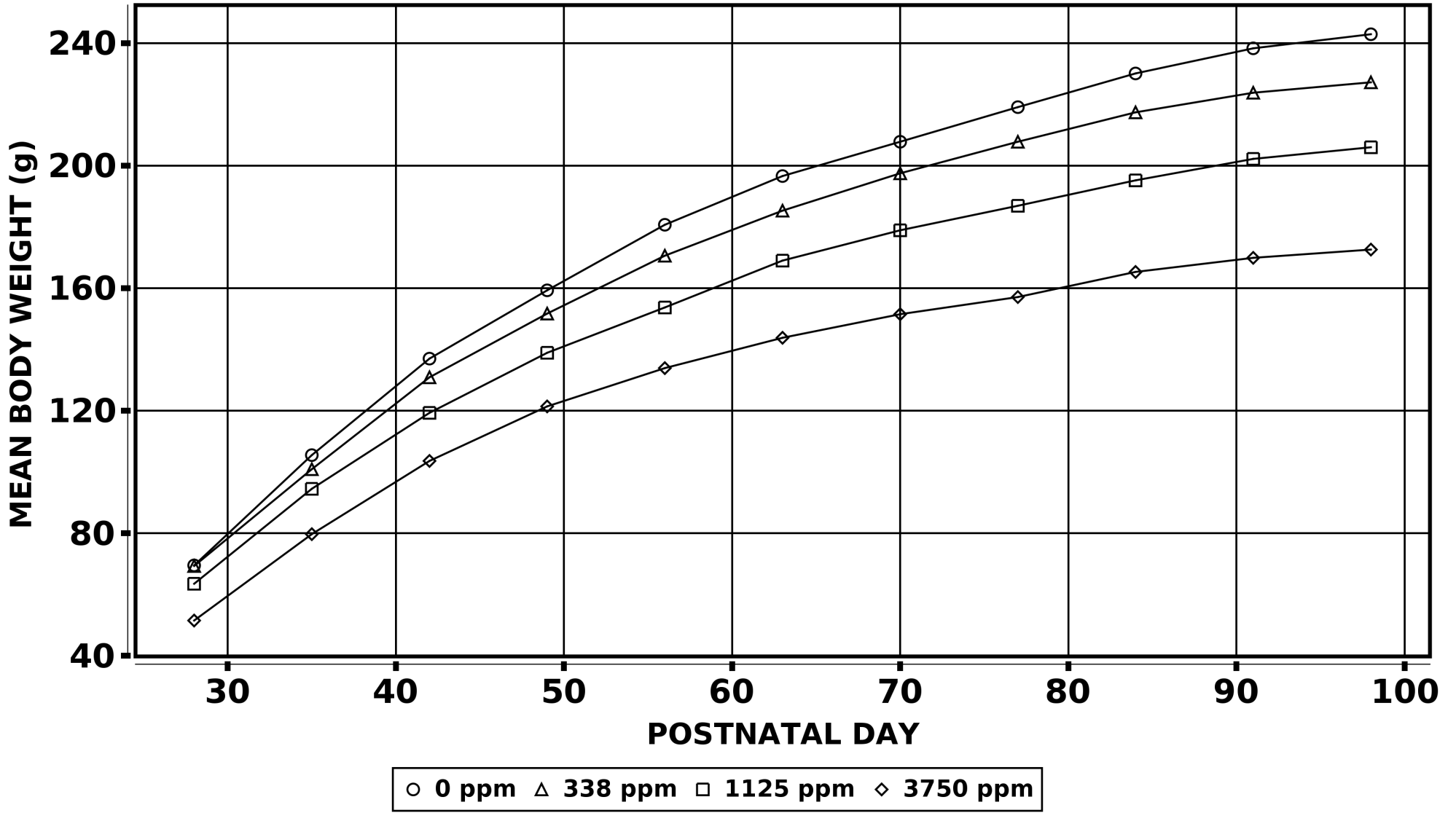

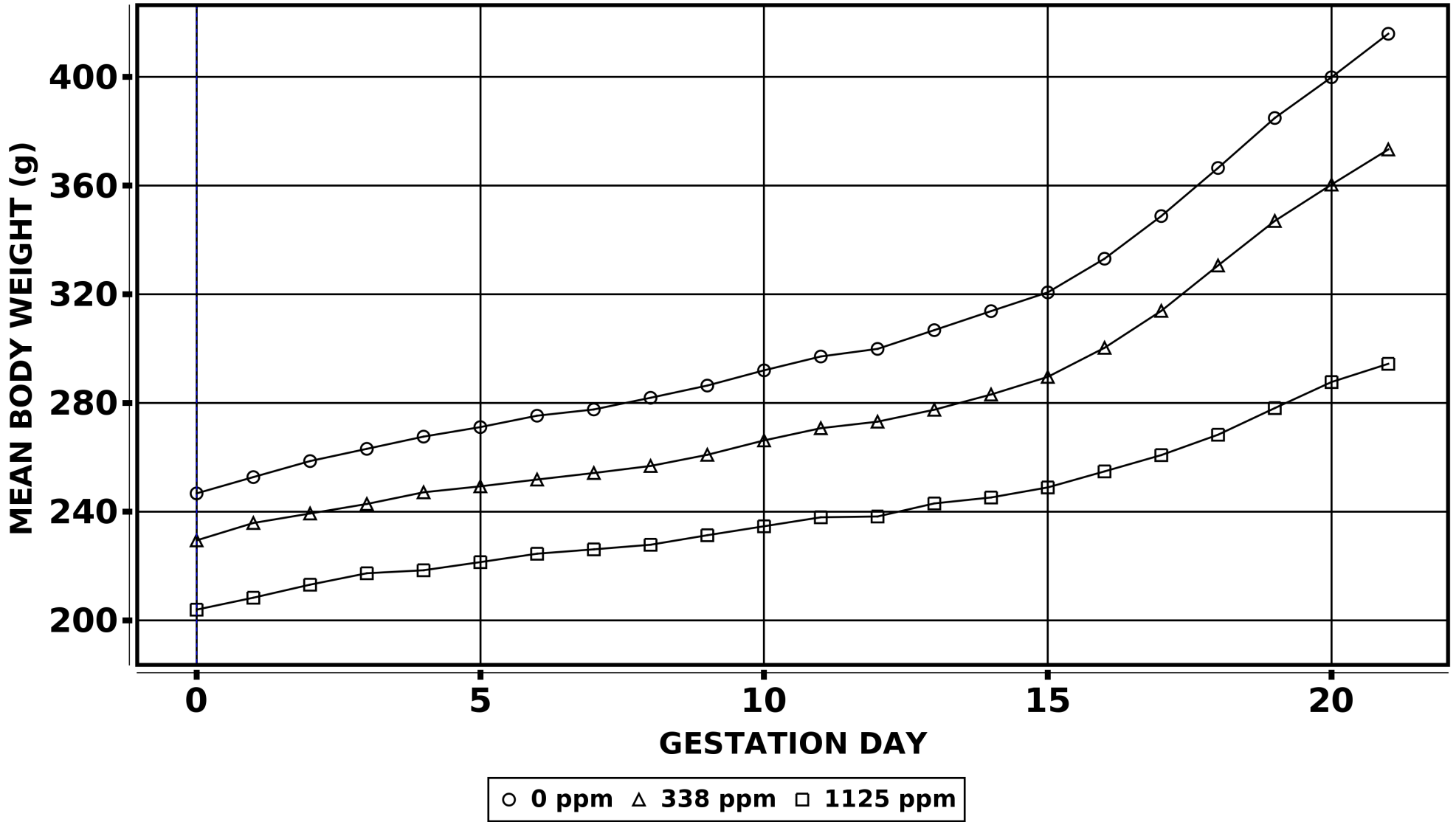

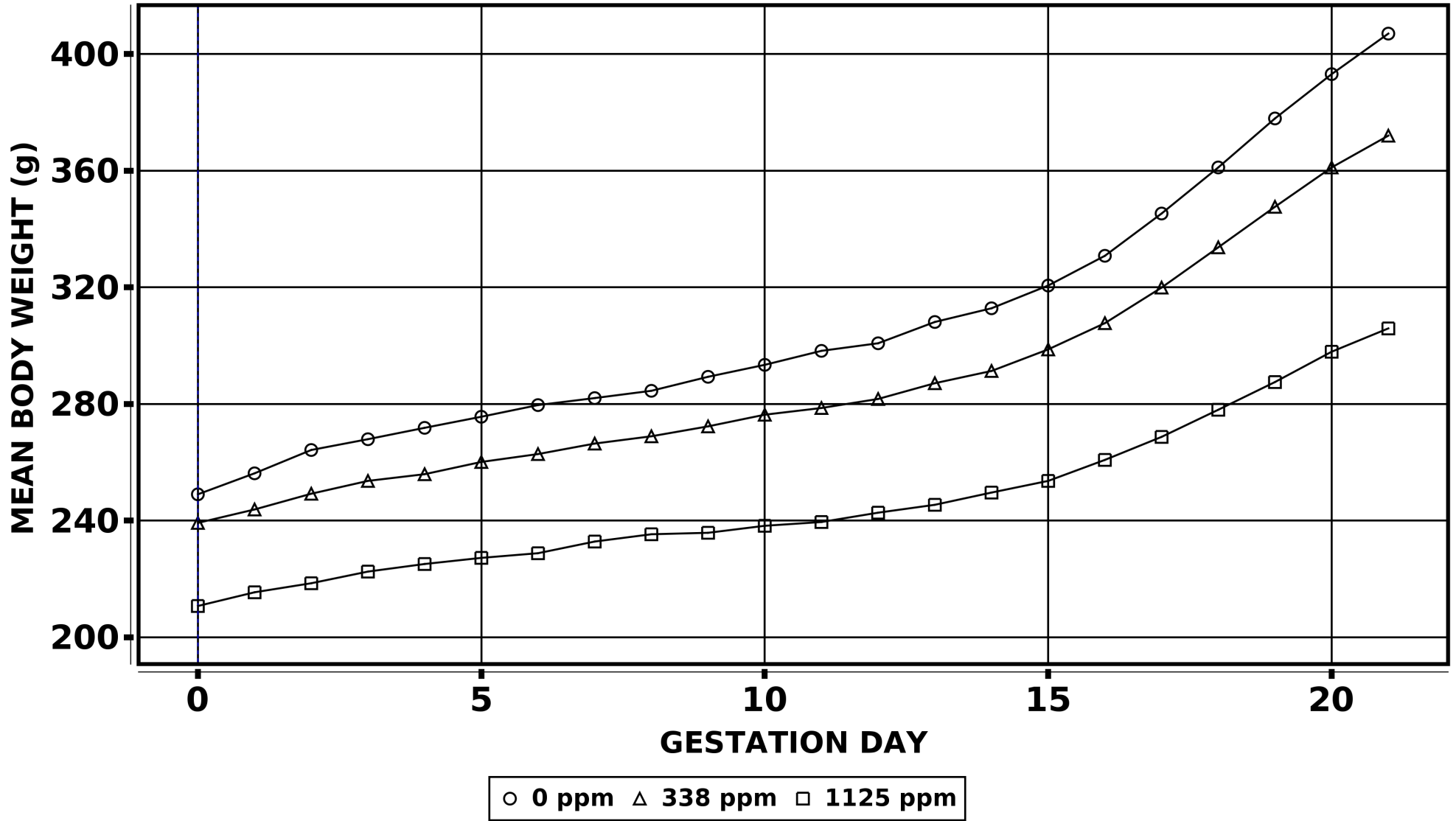

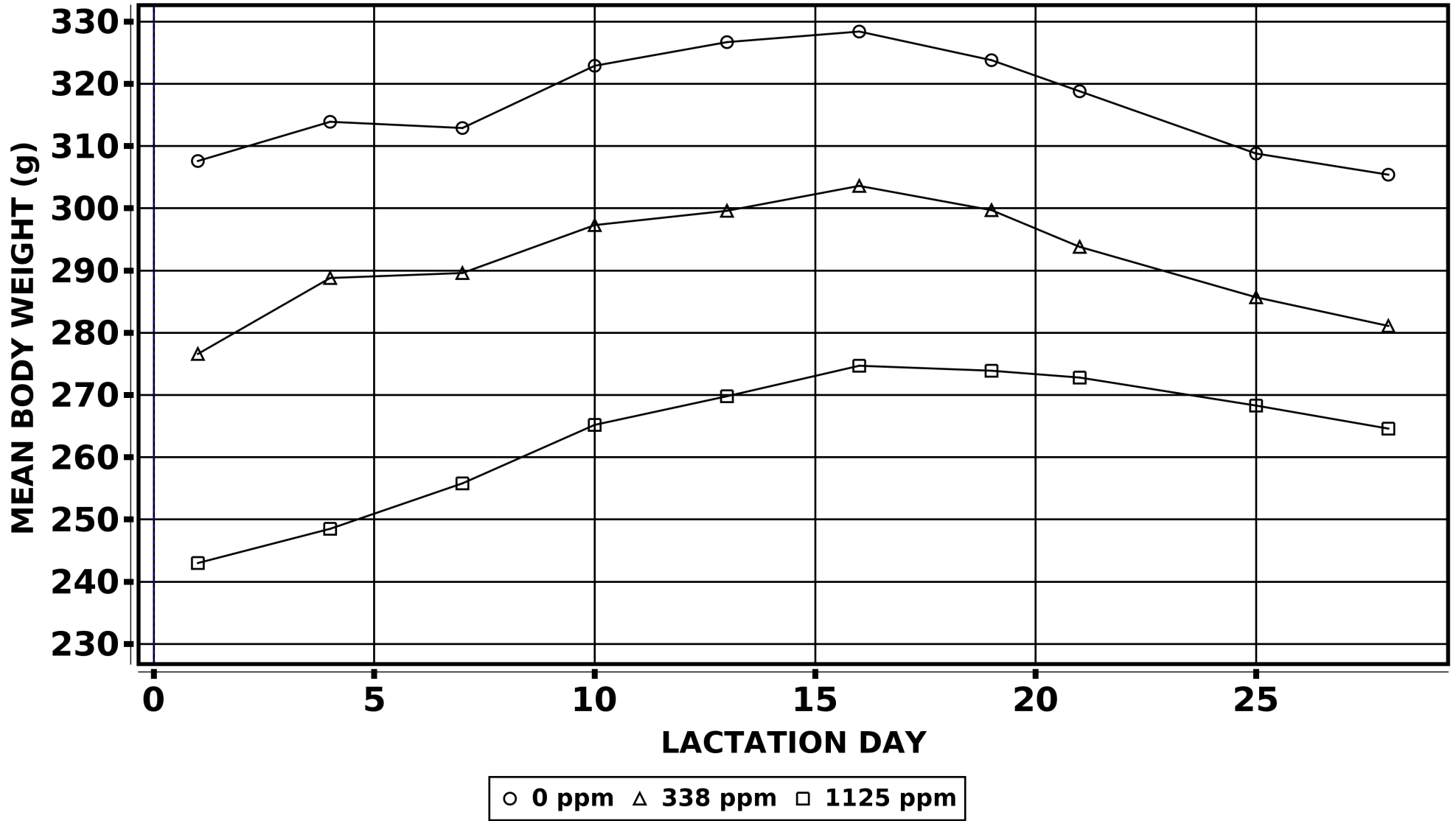

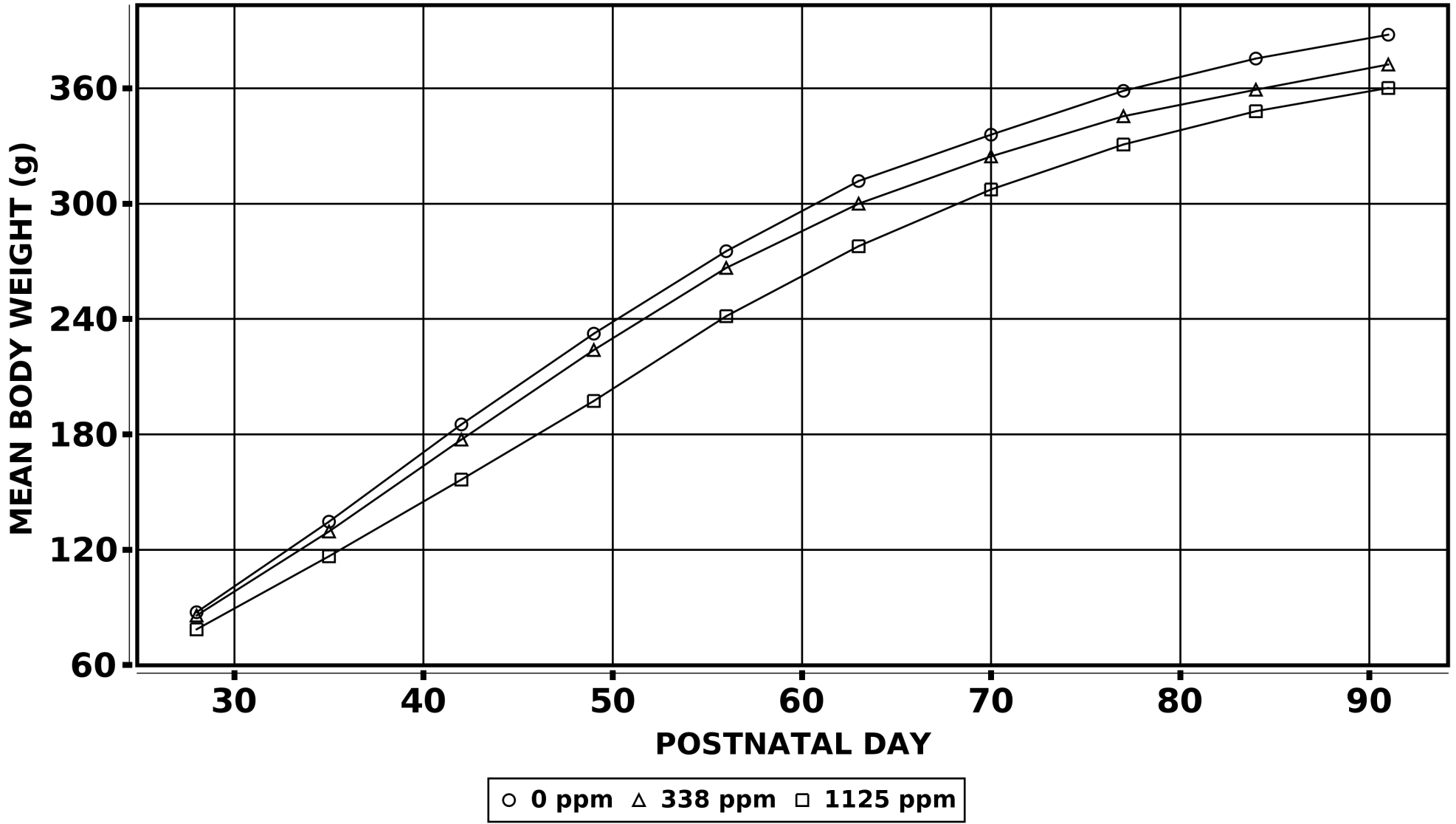

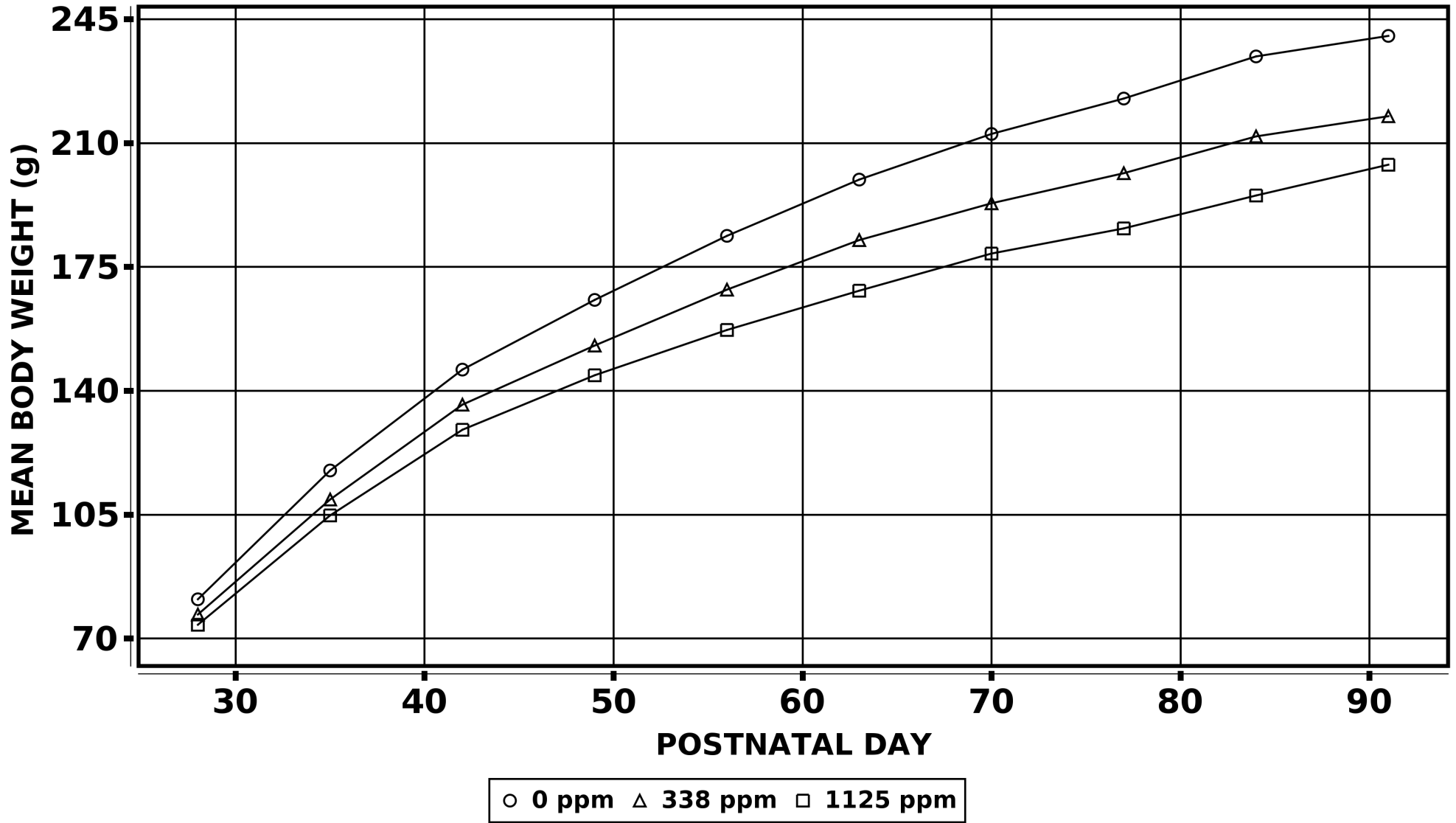

LEGEND

In multigenerational studies, body weights reported for all animals until mating; pregnant animals only during gestation and lactation; all animals post-weaning.

Postnatal Day, adults post-weaning

All F1 Females include all animals until mating or sacrifice except those removed on day of vaginal opening (pnd 26-39) for Mammary Gland Whole Mounts.

The F1 Males: All F1 Males includes all F1 males through postnatal day 91 except at postnatal days 86-89 F1 males designated as extra were removed. It includes only the F1 Parental cohort males from postnatal day 93 through 203 with postnatal day 213 representing the F1 Parental males that had not yet been sacrificed. The F1 Non-Parental cohort males were sacrificed on postnatal days 90 through 92.

The F1 3750 ppm animals were unable to produce a F2 generation, hence this group was not evaluated.
